Transport

The road network is made up of mainly B and C class roads with one A road. Car ownership is one of the highest in the County with an average of 1.63 cars per household compared to the County average of 1.36 cars per household. There are 6 bus services running daily in the community area operated by 4 different companies and covering 18 out of the 27 settlements. However, according to local surveys, 63% of the population say that they never travel by bus.

Road safety issues	In St Paul Malmesbury Without local residents are concerned about the number of vehicles, particularly HGVs and also the state of the Filands stretch to the Dyson's junction. Speeding, noise and volume of traffic are a problem in many areas. However, this is particularly a problem along the A429 where the road passes through small villages and settlements that are so narrow that the problems are magnified considerably. This not only detracts enormously from the quality of life of those affected, but also has severe safety implications for everyone.	A comprehensive survey should be carried out by the County Council as a matter or urgency, not only to count the number of vehicles using the roads, but also to look at the total impact of the traffic on the quality of life issues, including safety, noise nuisance and economic issues. Young People Comment

Consultation with young people indicates concern about HGVs driving through towns and villages, including some support for the idea for the High Street in Malmesbury to be closed to traffic excepting delivery vehicles
